AUTHOR DISCLOSURE TERMS AND CONDITIONS

The *Journal* author understands and accepts the following rules as required by the National Commission on Correctional Health Care in conformance with the Essential Areas and Policies of the Accreditation Council for Continuing Medical Education (ACCME), and rules of the Food and Drug Administration (FDA) and the American Medical Association (AMA).

1. **Disclosure.** Each author must complete and submit an Author Disclosure Form prior to publication of the manuscript in the *Journal*. The disclosure form shall be complete and truthful to the best of the author's knowledge. The author is required to disclose any financial relationship(s) with the manufacturer(s) of any product(s) or class(es) of product(s) discussed in the manuscript.
2. **Fair Balance.** Authors are required to prepare fair and balanced manuscripts that are objective and scientifically rigorous.
3. **Unapproved Uses.** Manuscripts that provide information related to non-FDA-approved uses for drug products and/or devices must clearly acknowledge the unlabeled indications or the investigational nature of their proposed uses. Authors who plan to discuss non-FDA-approved uses for drug products and/or devices must advise the sponsor of their intent.
4. **Use of Generic Versus Trade Names.** Authors should use scientific or generic names when referring to products in their manuscripts. Should it be necessary to use a trade name, the trade names of all products should be used.
5. **Commercial Supporter Influence.** All support associated with a CE activity, whether in the form of an educational grant or not, must be given with the full knowledge and approval of the accredited provider. No other funds from a commercial source shall be paid to the *Journal* publisher, editors, authors, or others involved with the supported activity. Authors should not be subject to direct input from a commercial supporter regarding the content of the manuscript.
